Subject: Constitution along with Cause List of cases fixed from 24.01.2022 to 27.01.2022 for hearings through Video Conferencing mode.


The Constitution along with list of cases fixed before various Benches from 24.01.2022 to 27.01.2022 for hearings through the Video Conferencing mode is enclosed.
