OFFICE ORDER


Sub: Steps for Expediting disposal of old appeals pending for more than five years-Reg.

1. The appeals are now heard by ITAT, Allahabad Bench, through physical mode in Open Court. Reference is drawn to modified SOP, dated 23.02.2022 for conducting physical hearings in Open Court by ITAT, Allahabad Bench, Allahabad, U.P.
2. It is directed that the following measures are to be implemented in order to enable Allahabad Bench of ITAT to dispose of **old appeals**, which are pending for **more than five years**, expeditiously:-
 - (i) The Allahabad Bench of ITAT will not, as far as possible, entertain adjournment application.
 - (ii) If at all adjournment becomes unavoidable, then the appeal may be adjourned for a period not exceeding five working days.
 - (iii) The reasons for adjourning the appeal should be properly recorded in the order sheet entry.
3. It is also directed that in case any adjournment application is moved through email or otherwise, the counsels/Departmental Representatives are directed to remain present for hearing through virtual mode, in case they are not able to appear in the Court Room for physical hearings. The Allahabad Bench of ITAT will resume Virtual hearing simultaneously for afore-stated limited purposes.
4. The Modified SOP dated 23.02.2022 for conducting physical hearings in Open Court by ITAT, Allahabad Bench, Allahabad, stand modified to the extent, as per our aforesaid directions.
5. The above directions will come into effect from Monday, 14th March, 2022
6. Inform all concerned for compliance.
