INCOME TAX APPELLATE TRIBUNAL CHENNAI BENCHES, CHENNAI

Sub-Constitution of Special Bench in ITA No 17/CHNY/2018 and CO No 116/CHNY/2018 in the case of Taewoong Logistics Pvt. Ltd. (Now known as J-Ark Logistics Pvt. Ltd.)

As per the order of the Hon'ble President, Income Tax Appellate Tribunal, a Special Bench is constituted comprising of Hon'ble President ITAT, Shri Aby T Varkey Judicial Member and Shri Manoj Kumar Aggarwal, Accountant Member to decide the following issues -

- (a) "Whether the appellant-assessee acting, as a Clearing & Forwarding Agent (CFA) is liable to deduct tax under Section 194C of the income Tax Act, 1961 while making payments of custodial charges to the Container Freight Station (CFS) and freight charges to airlines/shipping companies?
- (b) If not, whether the assessee would be liable to suffer disallowance under Section 40(a)(ia) of the Income Tax Act, 1961?"

The Appeal is listed for hearing before a Special Bench on 05.07.2024 at ITAT Chennai through Hybrid Mode.
