- 3. Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government shall ordinarily not exceed 3 years.

The selected candidates will have option to draw their grade pay plus deputation (duty) allowance or to have their pay fixed in the time scale of pay attached to this post in accordance with the Department of Personnel & Training OM No.2/29/91-Estt.(Pay-II) dated 05.01.1994 as amended from time to time.

- 5. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of the receipt of applications.
- 6. It is therefore, requested to circulate the vacancy circular of Deputy Registrar Group 'A' (Gaz.) among the eligible candidates of your office and applications received in the prescribed proforma (in duplicate) may be forwarded alongwith attested copies of ACR/APARs for the last five years and Vigilance Clearance/ Integrity Certificate, to the Assistant Registrar, Income Tax Appellate Tribunal, 3<sup>rd</sup> & 4<sup>th</sup> Floor, Old CGO Bldg., Prathistha Bhavan, M.K. Marg, Mumbai 400020 and email on admin.ho@itat.nic.in within 30 days from the date of publication of advertisement in Employment News.
- 7. The Competent Authority may forward the applications of only those candidates who could be spared immediately in the event of their selection. Applications received after the last date or without up-to-date APARs or otherwise found incomplete, will not be entertained. However, in genuine cases late applications may also be considered, if the delay is explained by reasonable cause.
- 8. The applications, complete in all respects, may be forwarded to the address mentioned above or to the nearest station/ Bench(es) of Income Tax Appellate Tribunal.
