The terms & conditions of the auction will be as under:

1. The bidder taking part in auction should deposit an amount of Rs. 5000/- in cash as deposit before the auction of furniture etc.
2. The earnest money deposit will be returned in respect of unsuccessful bidder.
3. The expenses if any for transport / shifting of old furniture equipments shall be borne by him only.
4. The successful bidder has to pay the earnest money not less than 25% of bid value in cash after adjusting the deposit immediately and balance amount has to pay within two days with the cashier of Income Tax Appellate Tribunal, Mumbai Benches, Mumbai. In case the balance amount is not deposited within two days, the earnest money will forfeited.
5. In case of dispute, the Auction Committee will take decision and the committee decision will be final.
6. In case the expected price of old furniture & equipment is not received in the auction, the Auction Committee reserves the right to cancel the auction without assigning any reason.
