"That the Ld. Appellate Authority has wrongly and illegally confirmed the disallowance claimed u/s 36(1)(vii) being the provisions of Bad & Doubtful Debts ignoring the all pleadings, evidence and material on record and misconstrued the provisions as well as the statutory instructions of Reserve Bank of India being the Statutory Body of Banks.?"

2. The above mentioned Special Bench cases are fixed for hearing on **29.10.2024**.
