ORDER

PER G.S. PANNU, VP :

This appeal by the assessee for the assessment year 2015-16 is directed against the order of learned CIT(A)-23, New Delhi dated 30th September, 2019.

2. Nobody appeared on behalf of the assessee at the time of Virtual Hearing before us.
