PER PAWAN SINGH, JUDICIAL MEMEBER:

1. This appeal by assessee is directed against the order of Id. Commissioner of Income Tax (Appeals), Valsad, dated 27.02.2019 for assessment year (AY) 2015-16.
2. The appeal came up hearing on 29th December 2020. The assessee has moved application dated 15.12.2020 for withdrawal of appeal on the ground that the assessee has settled the dispute with the under Vivad se Visvas Scheme - 2020 and had already received Form-3, issued from the office of Principal Commissioner of Income Tax, Valsad, dated 06.11.2020 copy of which is filed. The assessee prayed for withdrawal of the appeal.

3. The Id. Senior Departmental Representative (Id.DR) appearing for the revenue has no objection if the appeal of assessee is dismissed as withdrawn. Considering the contents of the application dated 15.12.2020 filed by the assessee, the assessee is allowed to withdraw his appeal. Resultantly, the appeal of the assessee is dismissed as withdrawn.
