ORDER

Per Bench:-

All these appeals filed by the assessee are directed against the separate orders of the Id. Commissioner of Income Tax (Appeals) (hereinafter the 'Id. CIT(A)') passed u/s 250 of the Income Tax Act, 1961 (the 'Act').

2. None appeared on behalf of the assessee. At the outset, it is noticed from the letters of the Ld. ARs of the assessee that the assessee had filed Form 1 and 2 under the Direct Tax Vivad Se Vishwas Act in respect of these appeal and the competent authority has issued Form no. 3, a copy of the said letters along with Form No. 3 is available in file, which is before us. Therefore, taking into consideration the fact that since the assessee have opted for the "Vivad Se Vishwas Scheme", there is no point in keeping the impugned appeals pending.
