ORDER

PER SHAMIM YAHYA, AM :

This appeal by the Assessee for the assessment year 2020-21 is directed against the Order dated 28/11/2023 of the DCIT, Circle Int. Tax 2(1)(2), New Delhi.

2. None appeared on behalf of the Assessee before us at the time of hearing. However, the assessee's AR, CA Sheetal Anand, has filed an application dated 12.2.2024, which has been placed on record, seeking withdrawal of the appeal. The contents of the said application are reproduced as under:-
