NOTIFICATION

Sub: Non-Functioning of regular Benches of the ITAT, Hyderabad Zone during summer vacation – regarding.

After considering the requests of various Bar Associations across the country, the committee headed by the Hon'ble President, ITAT, in the meetings held on 06/05/2025 and 11/09/2025 has approved non-functioning of regular Benches of the ITAT during summer vacation, Dussehra/ Diwali festivals and winter period.

2. Accordingly, it has been decided by Vice-President (Hyd Zone) that regular Benches of Hyderabad Zone i.e. Hyderabad & Visakhapatnam will not function during the period **from 18.05.2026 to 29.05.2026**.

3. In this regard, it may be noted that: -

- (vi) During the vacation period, there will be no sitting of regular Benches.
- (vii) On the request of parties, vacation Bench for hearing urgent matters, such as Stay Petitions, rectification applications etc., shall be constituted by the Hon'ble Vice President, Hyderabad Zone. However, pronouncement of orders can be done by the Members on 22/05/2026 & 29/05/2026.
- (viii) Matters fixed for hearing during the Bench non-functioning period shall be adjourned by the Registry to regular dates.
- (ix) The vacation period shall be utilized for judicial / technical research, dictating pending judicial orders, human resource capacity building and attending to administrative matters etc.,
- (x) During vacation, the Registry office shall function as usual.
