Sub: Non functioning of regular Benches of the ITAT, Mumbai Benches during Summer Vacation- Reg.

After considering the request of Income Tax Appellate Tribunal Bar Association, Mumbai, the Hon'ble President, ITAT has approved non-functioning of regular Benches of the ITAT, Mumbai during the ensuing Summer Vacation.

2. Accordingly, it has been decided that regular Benches of Mumbai Benches will not function during the period from 25.05.2026 to 05.06.2026.

3. In this regard, it may be noted that :-

- v. The vacation period shall be utilized for judicial/technical research, dictating pending judicial orders, human resource capacity building, bunching of appeals and attending to administrative matters etc.
- vi. During vacation, the Registry office shall function as usual.
